HEALTHCARE COST AND UTILIZATION PROJECT (HCUP) E CODE EVALUATION ADDENDUM WITH UPDATED INFORMATION FOR 2009

HCUP Method Series #2004-06 *Healthcare Cost and Utilization Project (HCUP) E Code Evaluation* evaluates the reporting of external cause of injury codes (E codes) on injury-related discharges in the 2001 Healthcare Cost and Utilization (HCUP) databases. This addendum provides similar information on the 2006, 2008, and 2009 HCUP databases. Please reference the complete report for additional details on methods.

The percentage of injury discharges with an injury E code is defined as:

The screens for identifying ICD-9-CM injury diagnoses and Injury E Codes are provided in Table 1 and Table 2. Injury diagnoses were counted only if they were reported as the first-listed or principal diagnosis. Injury E Codes were counted if they were reported in any position except the first-listed.
