### Applications will be accepted from October 17– November 23, 2022

The Agency for Healthcare Research and Quality (AHRQ) and AcademyHealth will recognize research published in peer-reviewed journals from **January 1**, **2021 – June 30**, **2022** that used Healthcare Cost and Utilization Project (HCUP) databases to explore and address healthcare research topics and issues. Work honored will demonstrate how HCUP data has contributed to these areas.

# Eligibility and article criteria for this nomination year has been updated. Please read the following carefully.

### **Eligible Applicants**

All nominations for the HCUP Award for Outstanding Research must have been published in hard copy format in a peer-reviewed journal between **January 1, 2021 – June 30, 2022**, and the article must have used an HCUP database in its analysis.

Authors may self-nominate or be nominated by another individual. Only one nomination per author/individual/research group will be accepted. For those nominating an individual, please notify the author. Complete information is available on the HCUP-US website: <u>https://www.hcup-us.ahrq.gov/news/awards.jsp</u>.

An AHRQ and AcademyHealth award committee will be selecting two articles to receive the Award, one for the Clinical Award and one for the Policy Award. In addition to the recognition, posters on the chosen recipients' articles will be produced on their behalf and displayed at the 2023 <u>AcademyHealth Annual</u> <u>Research Meeting (ARM)</u>, which will be held June 25–27 in Seattle, Washington. The winners will receive complimentary registration to attend ARM where they will be able to present their research during an HCUP session.
